The **Immunisation Team** is visiting on **13 December and 13 January** to deliver Influenza (flu) vaccinations via nasal spray to students in Years 7, 8 & 9.

**Please complete the e-consent form for your young person before midday on 8 December by visiting:**

If you do not want your young person to receive the vaccine, then please fill in the 'No' box.

If you do not want your young person to receive the nasal spray vaccine on the **basis of porcine gelatine**, please fill in the 'No' box indicating this, and you will be given the opportunity to consent for an alternative vaccination. This alternative vaccination is delivered by injection into the arm (intramuscularly) and does not contain any porcine DNA agents.

An automated email will be sent to you on completion of the e-consent form from Cinnamon Digital Applications (who host the website). If you do not receive this, please check in your junk email, or contact the Immunisation team on the email above.

Article 6(1)(e)

For the performance of a task carried out in the public interest or in the exercise of official authority.

Article 9(2)(h)

Necessary for the reasons of preventative or occupational medicine, for assessing the working capacity of the employee, medical diagnosis, the provision of health or social care or treatment or management of health or social care systems and services on the basis of Union or Member State law or a contract with a health professional.
