Dear parents and carers

The Immunisation Team are coming into school on **28 January, 7 March and 21 March** to carry out vaccinations against **Diphtheria, Tetanus, Polio (DTP)** and **Meningococcal ACWY (MenACWY)** for students in Year 9.

If you haven't already done so, please provide consent for this. If you do not want your young person to receive a vaccine, then please fill in the 'NO' box. If you do not respond the team may contact you.

Please complete the e-consent form by **midday Wednesday 22 January when the portal will close**. This allows time for our nurses to review and contact parents and carers if there are any concerns, prior to the session.

An automated email will be sent to you on completion of the e-consent from school.immunisations@nhs.net. If you do not receive this, please check in your junk or spam email or contact the Immunisation Team.

DTP is a 3-in-1 vaccination to protect against

- Diphtheria – a serious disease that can damage the heart, nervous system and in severe cases may kill
- Tetanus – a painful disease affecting the nervous system
- Polio – a virus that attacks the nervous system and can cause paralysis and can kill

This vaccination given in school in Year 9 completes the injections given pre-school. Your child needs a total of five doses of tetanus, diphtheria and polio to build up and maintain immunity. If you are unsure if your child has had their four previous doses, please check your child's red book, where their early childhood vaccinations are recorded.

Meningococcal ACWY vaccination protect against

The four main groups of meningococcal bacteria that can cause meningitis (infection of the layers that surround the brain and spinal cord) and septicaemia (blood poisoning). Meningococcal disease is rare but very serious and can lead to amputation, hearing loss, brain damage and scars. These diseases are known to affect older adolescents, especially if they go to university or training where they are living in accommodation with other young people.

GDPR

Article 6 (1) (e)

For the performance of a task carried out in the public interest or in the exercise of official authority.

Article 9(2)(h)

Necessary for the reasons of preventative or occupational medicine, for assessing the working capacity of the employee, medical diagnosis, the provision of health or social care or treatment or management of health or social care systems and services on the basis of Union or Member State law or a contract with a health professional.
